#### **30 Hours Funding**

Did you know that you may be entitled to 30 hours free childcare from September? Criteria

- Your child has to be 3 or 4 years old.
- Both parents must be working or the sole parent must be working in a lone parent family.
- Each parent earns, on average, a weekly minimum equivalent to 16 hours at National Minimum Wage. (For a parent aged 21-24 this would be approximately £111.20 per week. For a parent aged 25+ would be approximately £115.20 per
- Each parent must have an annual income less than £100,000.00.

You will be able to apply for the 30 hour scheme through a joint online application. The 30 hours can be particularly advantageous to those parents who struggle to find childcare over the holidays, as the hours can be spread over the year. Please see DfE website for more information.

We will keep you up-to-date with any further information about applying online.

## **Policy Updates**

This month we would like to draw your attention to 2 updated policies on our website – our Nutrition Policy and Health and Safety Policy. Below are the highlights of the policies:

#### **Nutrition Policy**

- All our menus are approved by Family Food First for nutritional value.
- Our meals are cooked by a health and hygiene certified person.
- We cater for all dietary needs.
- Children are encouraged to try all foods offered on their plate, but never forced.
- Dessert is always served, unless otherwise expressed by parents.
- Staff sit with the children at all mealtimes and good table manners are taught.
- Cooking and food preparation are included in the curriculum.
- Only milk and water are offered, water is available throughout the day.
- Sweet foods are limited to lunch time dessert only and generally consist of fruit and full fat milk.
- Cakes or sweet treats will NOT be accepted into the Nursery, alternatives for celebrations are displayed on Parents Information boards.
- Children wash their hands before and after every meal and after using the toilet.
- Breast feeding is encouraged and we can provide a private area for those wishing to breastfeed. We are also able to store breast milk.
- Children have at least one hour of physical exercise during their session at Nursery.
- Children are encouraged not to use bottles and / or dummies, but an open top cup.

#### **Health and Safety Policy**

- Parents must notify staff if their child is ill
- The person in charge of the Nursery will send home a child if they are suffering from sickness, diarrhoea or a communicable disease e.g. head lice, chickenpox, ringworm etc.
- The Nursery will telephone parents to ask to administer liquid paracetamol (calpol) if their child has a temperature, parents will then be asked to sign the medicine form on collection of their child.
- The Nursery has a minimum exclusion period of 48 hours for any child who has a stomach upset, sickness or diarrhoea.
- Children who have head lice and / or head lice eggs are not allowed into Nursery until the lice and / or eggs have been eradicated.
- The Nursery has an exclusion period of 5 days minimum for children who have chickenpox.
- Medicines can be administered at Nursery, if they are in their original container/box with the
  expiry date on and if they do not contain aspirin. Parents will have to complete a Medication
  Authorisation Form before medication can be administered by nursery staff. This also applies
  to all creams that are not nappy rash cream or sun cream.
- Parents of children who have longer term medication such as inhalers or epi-pens will need to complete a Long Term Illness form.
